In the G.O. 1st read above , orders were issued extending the benefit of compassionate appointment to the son/daughter/spouse of defence personnel killed in action and disabled in action belonging to Andhra Pradesh.

In the 2nd read above, orders were also issued extend the benefit of compassionate appointment to the younger brother/sister of the deceased/disabled defence personnel who remained unmarried at the time of death and also adopted son or daughter of the deceased / disabled defence personnel can be considered for appointment if the adoption had taken place legally at least five years prior to the demise or disabled defence personnel belonging to Andhra Pradesh.

In the G.O.3rd read above, orders issued canceling the scheme of compassionate appointment to the dependents of defence personnel ordered in 1st and 2nd read above with immediate effect and also furnished the -13- persons of dependents who are killed/disabled in action for appointment.

The Director, Sainik Welfare, Hyderabad in his letter 4th to 6th read above, has furnished proposals requesting the Government tot revoke the G.O.Ms.No.582 of Revenue (L.Ref) Deptt, dated:07-05-2003 and restore the scheme of compassionate appointment to the defence personnel killed in action and disabled in action as this noble act of the Government of A.P. will build the morale of serving soldiers and boost the spirit of ex-servicemen belonging to the A.P.

Government after careful consideration of the proposal of the Director, Sainik Welfare, Hyderabad and hereby decided to revoke the orders issued in G.O.Ms.No.582 of Revenue (L.Ref) Deptt., dt:07-05-2003 and restore the scheme of compassionate appointments to the dependents of defence personnel killed in action/disabled in action as ordered in G.O.Ms.No.42, Home (Genl.B) Dept dated:11-02-1993 and in G.O.Ms.No.617, Revenue (L.Ref) Department dated:27-09-2002.

The Director, Sainik Welfare, Hyderabad shall take action as ordered above.
