ORDER:-

Orders were issued in the G.O. first read above that members of the Defence services, who distinguished themselves by Acts of Gallantry in the field should be given monetary grants at the rates indicated against each.

The Chief of Army, New Delhi, has intimated that there is a disparity in the amounts of the awards authorized by various State Governments and felt this disparity is not in the best interests of the morale of the personnel of the Armed Forces particularly the winners of these awards hailing from different states and requested the State Government to reconsider for the increase in the existing rates to ensure uniformity in payment to the holders of each decoration etc.

3. The Government have examined the matter and in modification of the orders issued in the G.O. first read above hereby order, that members of the Defence Services who have been

awarded gallantry awards for acts of gallantry in the field should be given monetary grants at the rates indicated against each decoration as given below with immediate effect:

1.	Param Vir Chakra	- Rs. 22,500/-
2.	Ashoka Chakra	- Rs. 20,000/-
3.	Sarvotham Yudh Seva Medal	- Rs. 17,000/-
4.	Maha Vir Chakra	- Rs.15,000/-
5.	Param Vishisht Seva Medal	- Rs.15,000/-
6.	Kirthi Chakra	- Rs.12,000/-
7.	Uttam Yudh Seva Medal	- Rs. 10,000/-
8.	Vir Chakra	- Rs. 7,000/-
9.	Ati Vishisht Seva Medal	- Rs. 7,000/-
10.	Shaurya Chakra	- Rs 5,000/-
11.	Yudh Seva Medal	- Rs. 4,000/-
12.	Vishisht Seva Medal	- Rs. 3,000/-
13.	Sena Medal	- Rs. 3,000/-
