**ORDER:**

1. The Lt.Col,H.q., Andhra Sub Area, Secunderbad in his letter 2<sup>nd</sup> read above, has stated that during the last CMLC held on 8.10.2004,it was prposed to construct a Sainik Aramgath at Survey No. 44/2 at Somajiguda, Hyderabad. The Construction includes the Guest house and welfare complex for the Ex-Servicemen the Executive Engineer (R&B), Central Building Division, Hyderabad has funished the eastimate for construction of Sainik Aramgarh at Somajiguda, Hyderabad for an amount of Rs. 1.97Crores and requested the the

Director, Sainik Welfare to obtain and communicate necessary Administrative sanction. The proposal was that, 50% of the expenditure ie.Rs.98.5 lakhs each will be borne by State Govt. and Kendriya Sainik Board. It was finally agreed during the last CMLS-2005, that the State Govt. will release part of the amount of Rs. 50 lakhs during current financial year and the balance of Rs. 48.5 lakhs will be released in the next financial year.

2. In the reference 4<sup>th</sup> read above, the director, Sainik Welfare, Hyderabad has requested to accord administrative sanction with provision of funds of Rs.98.5 lakhs being State share During the current financial year 2005-06 and release the amount of Rs. 6-00 lakhs so deposited in State Tresasury which was released by the Kendriya Sainik Board, Govt. of India, New Delhi for construction of work of the Sainik Bhavan at Somajiguda, Hyderabad being the amount of Central share.
3. In the circumstances stated by the Director, Sainik Welfare, Hyderabad in the reference 4<sup>th</sup> read above, Government hereby accord administrative sanction (Administrative Order) for an estimated expenditure of Rs. 197.00 lakhs (Rupees one hundred ninety seven lakhs only) towards construction of Sainik Aramgarh at Somjiguda, Hyderabad.
4. The amount sanctioned in para 3 above, shall be debited to the following heads of account:-  
“6216 loans for housing – 80 General –MH – 190 Loans to Public Sector and othe undertakings – GH 11 – Normal State Plan – SH (09) Loans for construction of Sainik Aramgarh (to be opened)- 001 loans to A.P. State Police Housing Corporation Ltd.,

5. A.P. Police Housing Corporation Ltd., A.P., Hyderabad shall take up the construction within the funds released to them during the financial Year, 2005-2006.
6. The Director, Sainik Welfare, Hyderabad is requested to send necessary proposals to Finance(B.G.V)through A.P Police Housing Corporation, Hyderabad for making provision in B.E. 2006-2007 under State Plan.
