ORDER:

In the reference 1st read above, orders were issued sanctioning financial assistance at the rate of Rs.100/- per mensem to Non-Pensioner IInd World War Veterans and at the rate of Rs.75/- per mensem to Non-Pensioner widows of IInd World War Veterans, during their life time.

2. In the reference 2nd read above, orders were issued to enhance the rate of financial assistance to the Non-Pensioners IInd World War Veterans from Rs.100/- P.M to Rs.300/- P.M and Non-Pensioner widows of IInd World War Veterans from Rs.75/- P.M to Rs.200/- P.M with effect from 1.12.1998.

3. The Director, Sainik Welfare, Hyderabad in his letter 3rd read above, has stated that the large number of petitions are being received from the Ex-Servicemen Welfare Associations with a plea that the II World War Veterans may be considered for enhancement of financial assistance at least to a sum of Rs.600/- P.M and Rs.500/- P.M to the Non-Pensioner widows of IInd World War Veterans respectively taking into consideration the cost of living in these hard days and also on par with the enhancement that has been made by other States and requested to consider to issue orders enhancing the financial assistance to the Non-Pensioner IInd World War Veterans from Rs.300/- to Rs.600/- per month and to the Non-Pensioner widows of IInd World War Veterans from Rs.200/- to 500/- per month.

4. Government after careful consideration of the proposal, hereby decided to enhance the financial assistance to the Non-Pensioner IInd World War Veterans from Rs.300/- to Rs.500/- per month and to the Non-Pensioner widows of IInd World War Veterans from Rs.200/- to 400/- per month with immediate effect subject to meeting the expenditure with in B.E 2006-2007.

5. The Director, Sainik Welfare, Hyderabad shall take action accordingly for disbursing the financial assistance as enhanced above.
